# STOKES COUNTY AGRICULTURAL FAIR VENDOR GUIDELINES

- Vendors will be responsible for any/all taxes and any/all required licenses.
- Vendors will supply their own tent, tables, and chairs.
- Vendors agree to remain in their designated rental space during the entirety of the Fair.
- Availability of spaces and electrical outlets is on a first-paid, first- served basis.
- Any vendor may be asked to leave who attempts to sell merchandise that does not conform to that described on the application or behavior which the Fair Board finds objectionable.
- Vendors will be allowed to unload in an area near the vending location if possible.
- Exclusive selling rights to any product will not be attempted or guaranteed.
- A 50% refund will be given for vendor cancellations if the cancellation is requested by August 31, 2024.
- Should the Stokes County Agricultural Fair be canceled or postponed due to severe weather or unforeseen circumstances, donations will not be refunded.
- Vendors are to be set up by 1:00 pm opening day of the fair and removed from the fairgrounds by 5:00 pm Monday after the close of the fair.
- Only registered food vendors will be allowed to sell or give away food/beverage items. **NOTE: Food vendors are not allowed to sell Popcorn, Candy Apples, Sno-Cones, Cotton Candy, or Funnel Cake.**
- We reserve the right to deny registration for future festivals to those who do not honor our requests.

The Stokes County Agricultural Fair and/or the American Legion Post 290 will not be responsible for any damages, theft, or loss during the Fair. In signing, I agree to the guidelines set forth above and to not become part of any action, suit, or claim against the Stokes County Agricultural Fair or the American Legion Post 290, King, NC for any reason whatsoever.
